EVENT AUTHORIZATION FORM

THIS IS A LIABILITY RELEASE AND WAIVER AGREEMENT FOR THE THOMAS R. SMITH SEA SCOUTS REGATTA ON JULY 11, 2010.

The undersigned parents/guardians understand that an element of risk is involved in all sports, including sailing. Failure to observe and obey the regulations and discipline imposed by Chicago Yacht Club (CYC) and the Sea Scouts/Boy Scouts of America (BSA) will be cause for instant revocation of Sea Scouts privileges associated with this event. USCG approved life jackets will be required to be worn as directed on the docks and in the boats while Sea Scouts are engaging in these activities. All expenses incurred by the Sea Scout named below will be paid or guaranteed by the undersigned parent or guardian..

The Chicago Yacht Club provides various boats for the race event, and will be responsible for all damage due to normal wear and tear. Losses due to willful, wanton, negligent or careless handling of equipment shall be the responsibility of the individual Sea Scout or his or her parent or guardian. By signature to this form, the parents/guardians agree and guarantee reimbursement to the Chicago Yacht Club in the event of such loss or damage. The Junior Activities Committee of CYC or its representative shall have final jurisdiction over these matters.

Now, therefore, in consideration of the acceptance of the Sea Scout named below for this event, we, the undersigned, do hereby covenant and agree to hold harmless and to indemnify the Chicago Yacht Club, Sea Scouts/BSA, Mrs. Thomas R. Smith, all CYC members, officers and directors, the Junior Activities Committee and the personnel engaged or volunteering to help conduct Chicago Yacht Club or Sea Scouts/BSA activities from any and all liability for any claim, demand, suits or causes of action growing out of or in any way attributable to any injury or damage to the Sea Scout named below whatsoever, arising out of or in any way connected with the operation or participation in, or in any manner connected with the Chicago Yacht Club sailing activities connected therewith, or use of Chicago Yacht Club facilities.
