**NOTICE OF RACE**

The Chicago Yacht Club shall be the organizing authority.

**1. Rules**

The regatta will be governed by the *Rules* as defined in the Racing Rules of Sailing 2009-2012.

**2. Eligibility**

All V15 and Laser sailors are invited. 6 boats must be pre-registered by April 30, 2010 to form a class.

**3. Fees and Registration**

A \$10 late fee will be applied for boats registering after April 30, 2010. No registrations will be accepted after 09:45 Saturday, May 1, 2010.

**4. Schedule**

Packed lunches for Saturday are available for purchase with pre-registration, a limited number may be available Saturday morning for those who do not pre-order them. LUNCH IS NOT INCLUDED IN THE REGATTA FEE. LUNCH WILL BE EATEN ON THE WATER. WE WILL NOT BE COMING IN FOR LUNCH.

**Sunday, May 2**

10:00 am first warning, subsequent races to follow. No race will start after 1 PM.

**Lunch will be available on shore following racing (not included in entry fee).  
Awards on Sunday will be as soon as possible after the conclusion of racing.**

**5. Sailing Instructions**

Sailing Instructions will be available at check in.

**6. Safety**

All boats shall have bow lines according to class rules, or 1/4"x15' if there is no class rule, all dagger boards must be secured to boat.

**7. Scoring**

Scoring will be according to RRS, Appendix A2. 12 races are planned. One discard will be allowed after 6 races. Three races shall constitute a regatta.

**8. Awards**

Trophies will be awarded to the top three crews.

**9. Protests**

Pre-hearing mediation to be described in the Sailing Instructions will be used for protests. Only protests affecting the trophy standings will be heard prior to the Awards ceremony on Sunday. This changes RRS 63.1, 63.6 and 66.

**10. Launching and Parking**

Launching ramp is available, as is a crane. Parking is in the Chicago Park District pay lot.
