The ENTRANT must be a MEMBER of US Sailing, a National or Regional Class Association, a recognized Yacht Club of LMSRF, or provide written sponsorship by a MEMBER of the CHICAGO YACHT CLUB to be eligible to race.

The ENTRANT hereby acknowledges and agrees that any PERSONAL PROPERTY left on the premises of CHICAGO YACHT CLUB is at the sole RISK of the ENTRANT, and further, MUST BE REMOVED from CHICAGO YACHT CLUB no later than the date of the last scheduled event listed above (**November 21, 2010**). ENTRANT agrees that CHICAGO YACHT CLUB or its AGENT may remove ENTRANT'S personal property left on the premises after that date at the ENTRANT'S risk and expense.

The ENTRANT, in consideration for being permitted to ENTER any or all of the Races listed above, does for himself, his heirs, personal representatives and assigns, remise, waive, release, and forever discharge CHICAGO YACHT CLUB and its Directors, Officers, Members, Employees, Committees, and Agents and their respective heirs, personal representatives, successors and assigns of and from any and all manner of action and actions, cause or causes of action, suits, debts, accounts, damages, claims, and demands whatsoever in law, in admiralty, or in equity which the undersigned now has or may acquire by reason of injury to his person or his death, or loss or damage to his Yacht or any Personal Property arising out of or in connection with his participation in any of the said races, and does further agree to hold harmless CHICAGO YACHT CLUB and its Directors, Officers, Members, Employees, Committees, and Agents and their respective heirs, personal representatives, successors and assigns of and from any and all liabilities, damages, suits or claims whatsoever for accident or injury to the Entrant, Entrants crew, guests, yacht and personal property arising out of or in connection with participation in any of said races.
